8 of sentencing on the 17th day of October, 1977, with his counsel, CHARLES
9 ALTHAUSER, and the State of Washington being represented by JEREMY RANDOLPH,
10 Prosecuting Attorney, and JAMES R. MILLER, Chief Criminal Deputy; the defendant
11 having been charged by Information with the crime of Indecent Liberties, said
12 Information having been amended on the 1st day of August, 1977, to charge
13 the defendant with the crimes of Indecent Liberties, Counts I, II and III,
14 and Communication with a Minor for Immoral Purposes, Counts IV and V, and the
15 defendant having entered pleas of "guilty" on the 1st day of August, 1977, to
16 Indecent Liberties, Counts I and II, and the Court upon motion of the Prosecuting
17 Attorney having dismissed nolle prosequi Counts III, IV and V; and the Court
18 having heard and considered statements of counsel and defendant, and being fully
19 advised in the premises, Now, Therefore, it is

20 HEREBY ORDERED, ADJUDGED AND DECREED that the defendant is a sexual
21 psychopath and is not safe to be at large, and therefore should be recommitted
22 to Western State Hospital for treatment; it is

23 FURTHER ORDERED, ADJUDGED AND DECREED that the defendant is guilty
24 of the crimes of Indecent Liberties as set forth in Counts I and II of the
25 Amended Information on file herein; it is

26 FURTHER ORDERED, ADJUDGED AND DECREED that the imposition of sentence
27 against the defendant herein be, and the same hereby is, deferred pursuant to
28 RCW 9.95.210
RCW 9.95.210 for a period of five (5) years from date of entry of this judgment
29 upon the following terms and conditions:

30 1. That the defendant enter and successfully complete the Sexual

2 2. That within thirty (30) months from the date of entry of this
3 judgment, the defendant shall pay the sum of \$100.00 as courts costs incurred
4 herein; said sum payable to the Clerk of the Lewis County Superior Court;

5 3. That the defendant shall have no contact with children under
6 the age of fifteen (15) years unless under adult supervision;


7 4. That the defendant shall conduct himself at all times as a
8 law-abiding citizen with no infractions of the criminal law;


9 5. That the defendant shall promptly report to the Washington State
10 Office of Probation and Parole in Lewis County, follow the instructions
11 received therefrom, and implicitly abide by the rules and regulations
12 promulgated by the Board of Prison Terms and Paroles during the term of
13 probation herein; it is

14 FURTHER ORDERED that this order shall remain in full force and effect
15 until further order of this Court or until such time as the same is revoked,
16 modified or changed, or the period of probation is terminated by an order of
17 the Court, as provided by law.
