The defendant personally appearing before the Court for the purpose of sentencing on the 17th day of October, 1977, with his counsel, CHARLES ALTHAUSER, and the State of Washington being represented by JEREMY RANDOLPH, Prosecuting Attorney, and JAMES R. MILLER, Chief Criminal Deputy; the defendant having been charged by Information with the crime of Indecent Liberties, said Information having been amended on the 1st day of August, 1977, to charge the defendant with the crimes of Indecent Liberties, Counts I, II and III, and Communication with a Minor for Immoral Purposes, Counts IV and V, and the defendant having entered pleas of "guilty" on the 1st day of August, 1977, to Indecent Liberties, Counts I and II, and the Court upon motion of the Prosecuting Attorney having dismissed nolle prosequi Counts III, IV and V; and the Court having heard and considered statements of counsel and defendant, and being fully advised in the premises, Now, Therefore, it is

HEREBY ORDERED, ADJUDGED AND DECREED that the defendant is a sexual psychopath and is not safe to be at large, and therefore should be recommitted to Western State Hospital for treatment; it is

FURTHER ORDERED, ADJUDGED AND DECREED that the defendant is guilty of the crimes of Indecent Liberties as set forth in Counts I and II of the Amended Information on file herein; it is

FURTHER ORDERED, ADJUDGED AND DECREED that the imposition of sentence against the defendant herein be, and the same hereby is, deferred pursuant to NEW 9,75,200 RCW 9.95.210 for a period of five (5) years from date of entry of this judgment upon the following terms and conditions:

That the defendant enter and successfully complete the Sexual

2. That within thirty (30) months from the date of entry of this judgment, the defendant shall pay the sum of \$100.00 as courts costs incurred herein; said sum payable to the Clerk of the Lewis County Superior Court;

- 3. That the defendant shall have no contact with children under the age of fifteen (15) years unless under adult supervision;
- 4. That the defendant shall conduct himself at all times as a law-abiding citizen with no infractions of the criminal law;
- 5. That the defendant shall promptly report to the Washington State Office of Probation and Parole in Lewis County, follow the instructions received therefrom, and implicitly abide by the rules and regulations promulgated by the Board of Prison Terms and Paroles during the term of probation herein; it is

FURTHER ORDERED that this order shall remain in full force and effect until further order of this Court or until such time as the same is revoked, modified or changed, or the period of probation is terminated by an order of the Court, as provided by law.
